- b. At a trial where Open classes are offered, the total number of Nursery classes sanctioned may not exceed the greater of either the total number of open classes or the total number of days that the trial is sanctioned for. The scheduling of the Nursery classes is at the discretion of the trial host; however, no more than two sanctioned Nursery classes may be run in one day.

Discussion was held. Reason for the current rule was to prevent holding too many nursery in a row just to get dogs qualified. It was discussed that an extraordinary exception was made for one trial due to extreme weather conditions but there is nothing in the rules allowing waivers routinely.

President's Report

The USBCHA is made up of around 1100 members spread across the USA and Canada and is the pre-eminent organization overseeing stock dog field trials in the United States, and in Canada in partnership with the CBCA.

Partnerships are what make the USBCHA work. I'd like to take some time to highlight some of those partnerships and how they influence and add to this organization.

The first partnership is with our members who support the organization through their dues and their participation in trials throughout each year. Every Open and Nursery run you enter provides \$3.50 to the USBCHA. Of that money, \$1 is allocated to the current year's National Finals Host Committee to help fund the Finals. Another \$.050 goes to the USBCHA Secretary to partially compensate her for all of the hard work she does on behalf of all of you. The remaining \$2 goes into the general fund and most of that is returned to the membership in the form of funding for the National Sheepdog and Cattledog Finals as you will see from the attached Financial Statement.

A second group of members and non-members who are vital partners with the USBCHA are those among you and across the USA and Canada who host trials. Without trial hosts, we as an organization do not exist and you as handlers have nowhere to run your dogs. As a sanctioning body, we traditionally have had very

The next partnership is with the ABCA who provide close to 50% of the funding for the National Finals, both sheep and cattle, as well as providing additional prize money for ABCA members who place. However, the ABCA also provides half of the members of the National Sheepdog Finals trials committee and the ABCA Board of Directors votes on the selection of judges for the National Finals. Our mission and goals are the same; to safeguard and develop the working Border Collie and the two organizations work closely together to advance that goal.

Last night at the ABCA meeting, Amanda Milliken provided a brief history of the relationship between the USBCHA and the CBCA. Many of our members are also CBCA members and the CBCA is the only national organization that the USBCHA will co-sanction trials with, again highlighted the alignment between the mission and goals of the two organizations.

We have just concluded a renewal of our partnership with Purina which is a one year agreement, renewable for a further four years and represents an increase in Purina's commitment to the USBCHA. Purina has been a long term supporter of the USBCHA providing sponsorship, supporting the National Finals with donations of Purina products, supporting the World Trial team with team jackets, and sponsoring the Open Field Trial dog of the year. The new agreement with Purina will significantly increase Purina's level of sponsorship. The hard work on cementing this partnership was done by Ray Voight and Karl Gunzer on behalf of Purina, and Russel McCord, Lori Cunningham and John Campbell on behalf of the USBCHA.
